# **Community Employment on the rise**

Stone Belt's Employment Consultants have been hard at work supporting Individuals with Developmental Disabilities (I/DD) in their quest to secure employment in their communities, including Bartholomew, Brown, Lawrence, Monroe, and Owen counties. One of Stone Belt's Principles of Service states that "employment is a fundamental part of adult life."

Since July 1, Employment Consultants have helped twelve clients find great fitting jobs aligning with their vision of a good life. Recently, an individual interested in working with children took a First Aid and CPR course through Stone Belt. Having acquired these skills helped her procure an educational assistant position at New Hope for Families in Bloomington. Edgewood Primary School recently hired another person interested in working with children to monitor and help students in the lunchroom.

A significant amount of work begins way before a client interviews for a job. Employment Consultants support the client through a discovery process to learn about their interests. For example, what do they consider

to be a dream iob? What is their ideal working environment? Do they have the skills needed for the job? And what about transportation? They also work together to develop the soft skills required, like

time management, hygiene, and appropriate attire, to ensure the client is prepared and comfortable with the job expectations before even applying.

Stone Belt Employment Consultants throughout the agency are currently working with 73 clients to find their perfect job match. Once hired, the job coaching process starts. The Employment Consultant helps through the onboarding and training process. Employment Consultants advocate for accommodations, promotions, and other employment needs. Stone Belt has excellent relationships with several businesses that have hired individuals with disabilities. Currently, 79 clients are in supported employment and receiving extended services. The employment process proves that every step towards inclusion is a step closer to a brighter and more equitable community. Stone Belt is thankful for its lasting partnerships and is always looking for more opportunities in the future.

Group Homes did an excellent job of helping all of the clients of Blackstone House move to supported living settings and are in the process of assisting clients at Hite House to do the same. This has allowed clients to have more choice in where and whom they live with and has helped reduce the number of staff we need. They have also been supporting clients to get out of the house more. They hosted a prom in September. Clients and staff are doing an excellent job of supporting each other and working together to make events happen.

Supported Living has been helping many clients move. This allows clients to have more choice in where and who they live with. They have escorted many clients as they have traveled to places as far away as Ireland and as nearby as the Indiana State Fair. They have also recently assisted in wedding preparation for several couples and are always looking for ways to assist in developing new relationships and social connections for clients.

All of these changes, from leadership changes to Board of Director changes to service changes, are improving the quality of support we offer to the people we serve. I hope you all find time to enjoy the fall weather and activities. And I hope you embrace changes and adopt an attitude of curiosity and wonder.
